The preliminary evaluation was undertaken as follows:

1. Bidders were evaluated against eligibility criteria.
2. Bids were evaluated for eligibility & compliance.

Bid submitted by M/s. IT Consulting and Services for Package 3 did not meet the minimum eligibility criteria and hence was technically disqualified. The remaining 07 bids by vendors for the 3 Packages were evaluated to be compliant in the preliminary evaluation and progressed to the next stage of "Detailed Evaluation".

A Detailed Evaluation was undertaken of the 07 Bids submitted for all 3 packages. For this purpose, compliance-based criteria from the Tender Process were used. After a detailed evaluation, all the 07 bids were found to be fully compliant with all Technical and Financial requirements and were invited for Financial Bid Opening.
