9	Criteria for Proposal Evaluation:	<p><u>Preliminary Evaluation/Responsiveness</u></p> <p>06. Eligibility and responsiveness of bidders were determined based on the following eligibility/qualification criteria given in the Bidding Document:-</p> <ol style="list-style-type: none"> a. Bidder(s) must have at-least three (03) years of relevant experience. b. The bidder(s) must provide copies of purchase orders /supply orders / work orders or contracts to establish the required experience. c. Bidder(s) must provide Complete List of Client including details of at least two (02) current clients along with their contact information. d. Bidder(s) shall have National Tax No. and Sales Tax No. The bidder should be on Active Taxpayers List (ATL) of FBR. e. Bidder(s) must provide the leaflets/ brochures/ catalogs with the bid f. The bid and price schedule should be submitted on the prescribed format on company's letterhead. Both must be properly signed and stamped by the authorized person.



- g. Bid Security as mentioned at following ITB clause 13.1 must be furnished from scheduled Bank of Pakistan;
- h. Bidders must provide an Affidavit on judicial stamp paper of Rs. 100/- that bidder is not blacklisted by any public sector organization;
- i. Bidder(s) must submit Manufacturer or Authorized dealer's Authorization Form on the format provided in Section IV of the bidding documents with its bid.
- j. Bids shall remain valid for the period of 120 days as mentioned at ITB clause 14.1.
- k. The Bidder has to quote only one rate as per required specification. No alternate model/bid shall be accepted as per ITB clause 23.2

Detailed Evaluation

08. Detailed evaluation of bids of eligible/responsive bidder was carried out based on the evaluation criteria given in the bidding documents:-

- (i) Delivered Duty Paid Price only inclusive of all applicable indirect taxes (GST), duties, freight (transportation), charges, insurances & warranties, if any, etc.
- (ii) Evaluation will be done on the basis of most advantageous bid for complete requirement. Bids submitted for partial requirement shall be considered as non-responsive. Bidder are required to bid for 100% of the required quantity on Delivered Duty Paid price basis i.e. inclusive of all applicable indirect taxes (GST) & complete transportation & delivery charges, insurances & warranties etc. No offer on itemized basis will be accepted.
- (iii) The Bidder has to quote only one rate as per required specification. No alternate model/bid shall be accepted.
- (iv) Compliance to technical specification as proposed in Bidding Document.
- (iv) The items specified in the Bidding Documents are required to be delivered within given time period as mentioned in Schedule of Requirement.




10. Detail of Proposal Evaluation

<u>Name of Bidder</u>	<u>Result</u>
YouTree Services	The Bidder has to quote only one rate as per required specification. No alternate model/bid is accepted as per ITB clause 23.2. However, the firm has quoted different prices of a single item, thus declared Non-Responsive by the committee.
Furniture Revolution	The firm has submitted its quotation conforming the required specifications and Terms/conditions of ITB, thus declared Responsive by the committee.
Shabbir Construction Company	The firm has not submitted its complete offer as required by ITB. Bidder has not provided details of relevant experience, list of clients, ATL Status, Affidavit etc. thus declared Non-Responsive by the committee.
