Detailed evaluation was undertaken against bid submitted by the bidders and evaluated as below.

- 10. Details of Bid(s) Evaluation: Detailed evaluation was undertaken against bids submitted by the bidders **M/s. Commtel and M/s. Pronet (Pvt) Ltd** for Packages 1, 2 & 3. Bid Submitted by M/s. Pronet (Pvt) Ltd. for Package#1 did not meet the minimum eligibility criteria and hence Technically disqualified. However, Bids submitted by M/s. Pronet (Pvt) Ltd. for Packages#2 & Package#3 were found fully compliant with all technical and financial requirements. In Addition to this, Bids Submitted by M/s. Commtel for Packages 1, 2 & 3 were found fully compliant with all technical and financial requirements.
