Remarks: Total (15) firms participated in the pre-qualification process (through open frame work agreement and through E-pads) for the period of (03) Years i.e. 2023-24 to 2025-26. However after technical evaluation (11) above firms were recommended qualified for pre-qualification vendors & workshop (through open frame work agreement) & E-pads for (03) Years i.e. 2023-24 to 2025-26. Furthermore, remaining (04) firms namely M/S Siraj Engineering, Express Lub, and Modern battery disqualified due to failed to apply via E-Pads within stipulated time and M/S Toyota Hub disqualified due to failed to provide the CDR in the amount of Rs. 15,000/- in favour of DDO NHMP West Zone, as mentioned in SBD.
