MINUTES OF THE MEETING OF THE PROCUREMENT COMMITTEE IN SUBJECT: RESPECT OF TENDER FOR PROCUREMENT OF 02 E-PASSPORT PERSONALIZATION SYSTEM TENDER No. 01/03/24-ePP/LOG/DGIP.

The Department of Immigration & Passports floated international tender for procurement of 02e-Passport Personalization System vide TENDER No. 01/03/24ePP/LOG/DGIP on 06th April 2024 through International Financial Times (UK World Edition). The tender was purchased by the following firms:

The bid submission date for the subject tender was 10th June 2024 at 01:00 PM 2. and the bid opening was held at 01:30 PM. The following bidderparticipated in the tender:

3. As per PPRA Rule 38(B), the procuring agency can accept a single bid if (a) it meets the evaluation criteria, ensures compliance of specifications and other terms & conditions expressed in advertisement or bid solicitation documents; (b) is not in conflict with any provision of the Ordinance; (c) conforms to the technical specifications; (d) has financial conformance in terms of rate reasonability. The relevant rule has reproduced herein below:

38B. Single responsive bid in goods, works and services. -AC" BUS ANY

(1) The procuring agency shall consider single bid in goods, works and services Beogora en to if it-

(a) meets the evaluation criteria, ensures compliance of specifications and other terms & conditions expressed in advertisement or bid solicitation documents;



Provided that except unsolicited proposal, in case of pre-qualification proceedings single bid shall not be entertained.

It is important to mention that the procurement committee considered the single bid under PPRA rule 38B as according to the current working condition of the e-passport personalization machine, there has been no support of service given by the vendor. Since, the deployment and till date the machine is being run independently there has been no support or service given by the vendor since the deployment and till date the machine is being run independently by DGIP engineers theirselves without any support from the vendor. Moreover, over the period of time the performance of the machine has been affected to the extent that it does not print even 500 passports per day whereas the daily production volume of DGIP is more than 25000 ePassports. Moreover, the demand in Passports has a significant sharp increase of more than 50%. The second s qualified bidder stands to be in the winner here and so to remember of rate reasonability and the

general principles of procurement like economic efficiency \$ value for moneyas according to the

5. Keeping in view the rising trend of passport demand in Pakistan, it is expected to further increase in the near future whereas the existing production setup cannot fulfill even half of the production requirement. Hence, in order to meet the production requirements and ensure timely issuance of passports to the citizens of Pakistan, it is utmost important that the instant procurement is made without further delays as any delays in the process can lead to crisis at a National level since the core function of DGIP is the issuance of Passports to the citizens of Pakistan and any delays/hurdle in the process of the instant procurement would ultimately hamper the ability of DGIP from its core function.

6. Keeping in view the above considerations, the procurement committee proceeded with technical evaluation of the bid submitted by the bidder as per PPRA Rule "30-Evaluation of Bids". Consequently, the bid was handed over to Internal Technical Committee nominated by the DGIP for the purpose to conduct the technical evaluation of the proposal submitted by M/s Muhlbauer ID services. The Internal Technical Committee, vide Technical Evaluation Report at (Annex-A) declared the following bidder technically qualified:

7. The Technical Evaluation Report was shared with the qualified Bidder by uploading the Technical Evaluation Report on PPRA website on 26.06.2024. After completion of stipulated period of 07 days as per PPRA rules, the financial opening of bid was scheduled on 04.07.2024.

8. A meeting of the Procurement Committee was held on 04.07.2024 under the Chairmanship of Director (Nw/Logistics). The representative of M/s Muhlbauer was also present in the meeting. The committee opened the proposal submitted by M/s Muhlbauer and announced as follows:

9. Following the provisions of PPRA Rules, the financial offer quoted by the qualified bidder stands to be in line within the financial conformance of rate reasonability and the general principles of procurement like economy, efficiency &value for money as according to the budgetary quotation(s) obtained from potential vendor(s) for ePassport Bulk Personalization System as follows:

10. Hence, the budgetary quotation for 02 units of e-passport personalization system would be 8,431,000/- Euro(Annex-B)received from M/s Mulhbauer and budgetary quotation of Euro 10,009,440 received from M/s Thales whereas the financial offer quoted by the qualified bidder i.e. M/s Muhlbauer is 8,250,000 Euro which lies below the budgetary quotations received from M/s. Muhlbauer and M/s Thales.

RECOMMENDATION:

11. The procurement Committee concluded that the proposal submitted by M/s Muhlbauer ID Services against the subject tender is technically & financially compliant in terms of conformance to the technical specifications, terms & conditions of the tender document, not in conflict in any ordinance and has financial rate reasonability.

12. Based on the above conclusion, the Procurement Committee recommended that M/s Muhlbauer be declared as the successful bidder for supply of two e-passport personalization systems to Directorate General Immigration & Passports, Islamabad.
