On the basis of preliminary evaluation, the committee unanimously disqualified M/s **Tayyab Traders** due to non-compliance of clause No-2.1, 2.4, 2.5 & 2.9 of preliminary Technical Evaluation and M/s **Galaxy Engineering Services** due to non-compliance of clause No-2.4 of preliminary Technical Evaluation. Procurement Committee recommended to open the Financial Bids for technically Qualified bidders in next phase.

As recommended by the Procurement Committee, opening of Financial bids of the tender regarding Procurement of Furniture & Fixture mentioned above, a meeting of Procurement Committee meeting for opening of Financial Bids of the technically qualified vendors was held on 19th July, 2021. 
