## NAME OF WORK: REPLACEMENT OF SWEET EARTH WITH MOORUM COURSE ON THE PLAY FIELD OF KPT FOOTBALL GROUND KEAMARI.

#### INTRODUCTION

The KPT Football ground Keamari was developed by KPT in the year 2015 for the provision of healthy sports facilities to the employees of KPT residing in the Keamari area, since then the same was in use of KPT Employees as well as the local residents of Keamari. Subsequently, Chairman KPT visited the football ground on 02/12/2021 along with the officials of KPT and upon request of the footballers, directed to replace the existing sweet earth on the play field with the Morrum course for the better provision of play field.

The Assistant Executive Engineer (KV) in the light of directions surveyed the ground and has prepares an Estimate for attending the necessary required works as the same are beyond the capacity of KPT in-house arrangement.

The scope of works, is as under:-

Taking out the existing layer of sweet earth disposing off same and further replacing with the Morrum course on the play field. (Morrum supplied through KPT stores department)

Accordingly, Tenders for the work were invited through KPT / PPRA Websites and receive on 12-04-2022, accordingly under rule 36(a) of PPRA.
