As per comparative statement shown above M/s PKG International Shipping & Logistics (Ltd) quoted the conditional rates in terms of percentage which is not acceptable while M/s Khyber exports quoted the fixed rate as service charges for clearing of customs assignments on the behalf of Directorate General I&P.

14. The purchase committee recommended for hiring the services of M/s Khyber Exports as custom clearing agent, on the basis of above quoted rates.
