# 1. Evaluation of Bids (ITB 34)

#### **Evaluation Criteria (ITB 34.2)**

The Procuring Agency's evaluation of a Bid may take into account, in addition to the Bid Price quoted in accordance with ITB 14.8, one or more of the following factors as specified in ITB 34.2(f) and in BDS referring to ITB 34.6, using the following criteria and methodologies.

### (a) Performance and productivity of the equipment

(i) Performance and productivity of the equipment. An adjustment representing the capitalized cost of additional operating costs over the life of the Goods will be added to the Bid price, for evaluation purposes if specified in the BDS ITB 34.6. The adjustment will be evaluated based on the drop in the guaranteed performance or efficiency offered in the Bid below the norm of 100, using the methodology specified below.

# 2. Criteria to conclude a Framework Agreement(s) (ITB 40)

# Criteria for a Single-Supplier Framework Agreement:

The Procuring Agency will conclude the Framework Agreement with the Bidder who's Bid has been determined to be:

- (a) substantially responsive to the Bidding documents; and
