HOW TO APPLY & GENERAL CONDITIONS

- Candidates should submit an online application against each post at <https://apply.sts.net.pk>
- Candidates are required to upload the following documents on the portal while applying online: **CNIC (front and back sides), Domicile, PRC/Form-D, one recent photograph, and all academic documents with percentage marks issued by the concerned university or any equivalent certification.**
- After completing the online application, candidates can download a system-generated challan of **Rs. 700/- (Rupees Seven Hundred Only)**. The challan can be paid at any branch of **ABL Bank Ltd** or via the **MyABL app**. Alternatively, candidates may use the **1Bill reference number** to pay through the internet banking portal of any 1Bill-linked bank. **(This fee is non-refundable)**
- Candidates with disabilities are required to upload a CNIC bearing the **wheelchair logo** issued by **NADRA**.
- Candidates awaiting their results or not possessing the required experience (where applicable) are not eligible to apply.
- No query shall be entertained **15 days** before the schedule of the MCQ's based written test.
- All positions are purely contractual and non-pensionable, to be filled initially for a period of one year on a lump sum package, with no long-term benefits and no prospect of regularization at any stage in the future. However, the contract may be extended based on satisfactory performance, in line with the company's requirements and policies/rules.
- General age relaxation has already been included in the age limits mentioned for each category. No further relaxation will be granted, except for candidates belonging to Scheduled Castes, Buddhists, FATA, Gilgit-Baltistan, and AJK residents, who are entitled to a three (03) year relaxation in the upper age limit. Government servants or serving employees who have completed two (02) years of continuous service as of the closing date for receipt of applications must apply through the proper channel.
- In-House induction quota for SEPCO employees having prescribed qualification and criteria meant for direct induction, subject to the condition that they will appear in induction examination for the post of Assistant Manager (Commercial) / RO (Sr. No. 02).
- Candidates who have been dismissed from service, debarred from future employment, or have a criminal record are not eligible to apply.
- Only shortlisted candidates will be called for the test/interview.
- The test will be conducted in major cities of Pakistan, namely **Islamabad, Karachi, and Sukkur**. Candidates are required to select their preferred test center carefully, as no change of center will be entertained after the submission of the application.
- Candidates may contact SIBA Testing Services (STS) for any queries, inquiries, or complaints regarding applications, admit slips, MCQ's based written test, results, and the display of provisional and final lists of candidates, etc., at the STS Helpdesk/Call Center at **#071-5644200-6** or via email at sts@iba-suk.edu.pk.
- A candidate's degree with Cumulative Grade Point Average (CGPA) will be evaluated according to the HEC standard chart, which is available on the HEC website.
- The test date and venue shall be intimated later via SMS and on the SIBA Testing Service (STS) website. Further, all updates and notifications about the test date, admit slip, result announcements or any other information shall be uploaded on the STS/website/portal as well. In this regard, candidates must visit the portal/website from time to time.
- The cut-off date for determining the eligibility of candidates in terms of age, qualification, domicile, etc., shall be the last date of the advertisement.
- Candidates are advised to apply for only one position.
- Incomplete applications will not be entertained. Any concealment or misrepresentation of facts at any stage will result in the disqualification of the candidate.
- Minimum passing marks in MCQ's based written test will be **50%**.
- Passing the MCQ's based written test does not guarantee employment for any candidate.
- SEPCO reserves the right to increase or decrease the number of posts or cancel the recruitment process at any time without assigning any reason.
- No TA/DA will be allowed to candidates for the test or interview.
