- xiii. Water, Sewerage regular maintenance & Janitorial services etc.
- xiv. Adequacy of rain water drainage on main & auxiliary roads in the vicinity of building.
- The ideal location may be located in any commercial area of Lahore preferably on Mall Road, Main Boulevard Gulberg, Jail Road, Ferozepur Road, Model Town, Garden Town or nearby vicinity of above locations, easily accessible via local transport with minimal rush hour-congestion.
