## **Auction Terms and Conditions**

- 1- Participants must have Valid / Original CNIC.
- 2- Pay Order / Cash Receipt of PKR 5,000/- as Tender/Auction Fee (Non-Refundable) is required to participate in auction process. This Auction Fee can be deposited in shape of Pay Order in the name of PIA or can also be deposited with PIA Cash Counters at PIA Booking Office RWP/ISB and at IIAP Islamabad against a Cash Receipt.
- 3- For registration purpose the Bidding Parties / Individuals must bring Original / valid CNIC along with Auction Fee Cash Receipt.
- 4- **All the bidding parties / Individuals must submit Earnest Money of PKR 1,000,000/- (one million) for Lot # 01, PKR 100,000/- for Lot # 02 to # 05 for each lot, in the shape of Pay Order in favor of Pakistan International Airlines, which is Refundable to un-successful bidders.**
- 5- Only those parties / individual would be allowed to enter / participate in the auction who will submit auction fee and earnest money pay order to PIA.
- 6- The successful bidder(s) will be required to deposit amount equivalent to 25% of the total bid value within two working days in shape of pay order in favor of Pakistan International Airlines and remaining 75% within Five working days after the auction otherwise PIA reserves the right to forfeit earnest money / 25% deposited amount. (Only Pay Order in favour of Pakistan International Airlines will be acceptable. Bank Guarantee, Call deposit, Cheque and any other payment instrument will not be entertained).
- 7- 10% Income Tax for filer & 15% in case of non-filer (if applicable) as per Govt. regulations which will be added up in offered rates. Highest bidder will be required to deposit total amount inclusive of 10% or 15% Income Tax with PIA Accounts Officer against Cash Receipt.
- 8- After approval, successful bidder(s) will be required to remove the auctioned material within 2 Months / 60 days' time, after lapse of 60 days PKR 5,000/= per day will be charged as warehouse charges, and this concession will only be for next 30 days only. In case, successful bidder(s) fails to remove the auctioned items/debris even after elapse of allowed 30 days, PIA Management reserves the right to forfeit the Earnest money and total amount deposited with PIA.
- 9- The above mentioned lots will be sold as WHOLE i.e. the LOT will not be split further (piecemeal offers for any single item(s) is not acceptable) and OFFERS must remain valid for Sixty days.
- 10- All participants/bidders to inspect/check the material carefully on given days / time mentioned above well before tender opening. No claim whatsoever will be accepted after auction proceeding.
- 11- All prospective bidders/participants to bring original CNIC to participate in auction/sale proceedings on the Auction Day i.e. 27-01-2021
- 12- All equipments being sold as scrap without any document i.e. Bill of Entry, Invoices etc. PIA will only issue NOC for the equipment if required.
- 13- **The Successful bidder of lot # 01 will be responsible for complete dismantling of the Sheds, removal of debris / leftover and proper disposal at reasonable place.**

- 14- The successful bidder(s) will be responsible if PIA property/belonging is damaged during dismantling and removal process.
- 15- Non-compliance with any of the terms & conditions will be liable to debar for participation in the auction process.
- 16- All Government of Pakistan applicable taxes (in addition to the bid value) will also be payable by the bidder(s) against accepted bid(s) if applicable.
