The Box will be sealed and no tender documents would be allowed after the specified time. Technical offers would be opened after half an hour after sealing the Box in the presence of the bidders who wish to attend. No tender would be sold on the last day i.e., day of submission.

5. Advance Income Tax will be recovered from the successful bidder/ licensee under Section 236-A of Income Tax Ordinance 2001. Defaulters of PAA dues are not eligible to apply. Late, ambiguous and / or conditional tenders shall not be entertained.

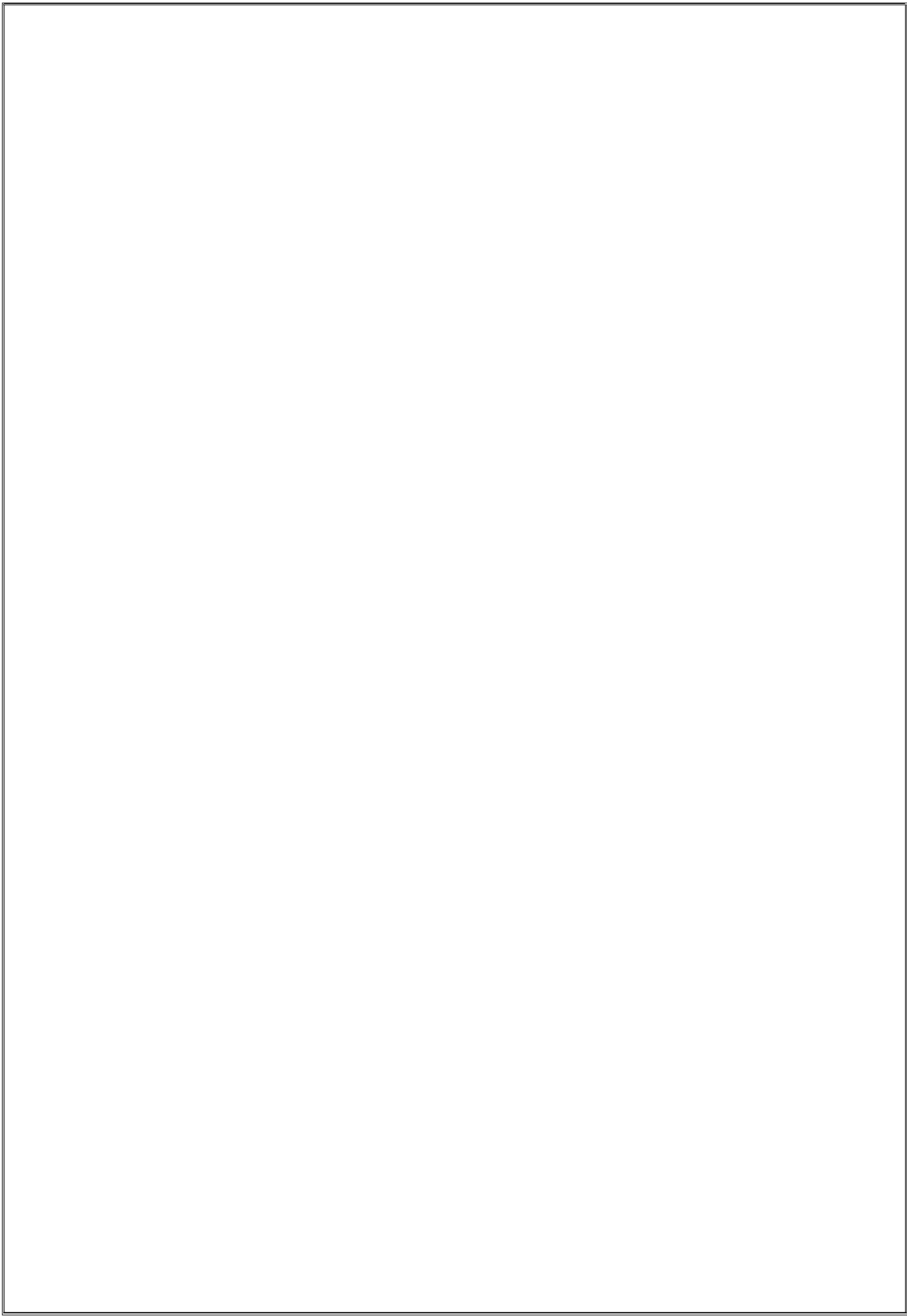
