- 4. A bank draft or pay order for Rs. 120,000/- in favor of "Pakistan Airports Authority" as earnest money must accompany the tender documents. Tenders without earnest money will not be considered.
- 5. The original bid security must be submitted to the office of the Divisional Engineer ES Civil Landside IIAP, Islamabad in original before the bid opening date and time. Copy of the bid security must be uploaded on EPADs alongwith tender documents. Bids without the receipt of the original Bid Security in hard form prior to the bid opening time and date will not be entertained.
- 6. Pakistan Airports Authority reserves the right to accept or reject any or all bids with valid reasons, which will be communicated to bidders upon request.
- 7. Bidders must submit the following documents in original at the time of bid opening and upload a copy of the same on EPADs with their bidding documents:

  - b) Power of attorney on non-judicial stamp paper with a minimum value of Rs. 500/- (if applicable)

  - d) Copy of valid income tax/active taxpayer status, GST and professional tax registration.
