**TERMS AND CONDITIONS:**

- a) Pakistan Airports Authority (PAA) invites bids from all OGRA-registered Petroleum Service Providers located within a 5 km radius of the Civil Aviation Training Institute (CATI), Hyderabad / Hyderabad Airport for the supply of Petrol, High-Speed Diesel (HSD) and lubricants. The contract shall be for the supply of Petrol and HSD to CATI Hyderabad / Hyderabad Airport for a period of two (02) years (extendable to another 01-year subject to satisfactory performance), effective from the date of execution of the agreement.
- b) Bidding shall be conducted in accordance with PPRA Rule 36(b): Single Stage – Two Envelope Procedure; Technical Envelope must include: Valid OGRA registration certificate, FBR registration and Active Taxpayer certificate, Documentary proof of business location within a 5 km radius of CATI / Hyderabad Airport. Financial Envelope must include Financial offer for Petrol, HSD and lubricants.
- c) The last date for submission and date of opening of bids is **Tuesday, 27<sup>th</sup> May 2025**. Bids must be submitted no later than **02:30 PM** on the said date in the Tender Box located at the Logistics Section, Civil Aviation Training Institute (CATI), Hyderabad. Bids will be opened at **03:00 PM** on the same day in the Conference Room, CATI Hyderabad, in the presence of bidders or their authorized representatives.
- d) Tender forms will be available **Free of cost** from the office of the Officer In-Charge Logistics, CATI Hyderabad, between 09:00 AM to 05:00 PM, up to **Monday, 26<sup>th</sup> May 2025**. Interested parties may obtain the Tender Document by submitting a request letter for the participation in tender signed by authorized representative on company letterhead.
- e) Detailed terms and requirements are provided in the Tender Document.
- f) PAA reserves the right to reject all bids or proposals at any time prior to acceptance, in accordance with PPRA Rule 33. Upon request, PAA shall communicate the grounds for rejection to any supplier or contractor, although it is not obligated to justify those grounds.
