

- Pakistan Airports Authority (PAA) invites sealed bids from eligible Service Providers for "PROVISION OF TRAINED SECURITY GUARDS (64 SECURITY GUARDS AND 04 SECURITY SUPERVISOR) (ALL EX-SERVICEMEN) THROUGH OUTSOURCE CONTRACT FOR CIVIL AVIATION TRAINING INSTITUTE AND HYDERABAD AIRPORT" for period of 02 years (extendable for 06 months only).
- 2. Service Providers having active NTN and Professional Tax Certificates are eligible to participate in the Bid for abovesaid services.
- Bids must be submitted electronically on PPRA's E-PADS portal http://eprocure.gov.pk by or before 27th May, 2025, 1100 Hrs as per conditions set out in bidding documents available on PPRA E-PAD as per conditions guidelines provided by PPRA from time to time. Bids will be opened on same day at 1130 Hrs at CATI Hyderabad.
- 4. The Bidding shall be conducted in line with the single stage two envelope procedure prescribed under Public Procurement Rules 2004, e-Pak Procurement Regulations, 2023 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the PPRA (from time to time), and is open to all eligible bidders registered on EPADS.
- 5. Original instrument of Bid Security (in sealed envelope) must be submitted on the date and time of opening of Bids, and a scanned copy must be attached to the Technical Proposal in the Bid and submitted on E-PADS. No Bid will be considered if bid security in the shape of pay order / bank draft is not attached with the tender or any false information / document is provided. Bid Security amounting to Rs.2,000,000/- shall be in favour of PAA DISBURSEMENT CATI.
- 6. Conditional bids will not be acceptable. PAA reserves the right to reject any or all bids as per PPRA Rule 33.
- 7. <u>Warning:</u> Pay Order / Bank Drafts or any other financial instrument submitted by the 'Bidders' and 'Service Providers' as 'Earnest Money / Bid Security' and 'Bank Guarantees', if found fake or dishonoured by Issuing Bank / Financial Institution at any Pre- or Post Stage of the case would call for blacklisting and legal action as per law of the land.
