4. Terms and conditions

- 4.1 The material/items will be disposed of on "as is where is" basis has been divided in two lots.
- 4.2 The bidder will be required to submit this document completely filled.
- 4.3 Detailed list of auction items must be collected from NADRA RHO Multan before inspection of items.
- 4.4 Earnest Money Deposit Rs.50,000/- (refundable) in name of "NSRC Disbursement Account RHO NADRA Multan" should accompany the Auction Bid. Earnest Money of unsuccessful bidders will be returned immediately after closing of bidding process.
- 4.5 All bids without Earnest Money or with less Earnest Money, will be rejected.
- 4.6 The material/items can be inspected at RHO NADRA Stores & MT Office, 1902/7-A Shah Shams Road, Near Chowk Rashidabad Multan and DRO Vehari (Plot No. 49/28 Muslim Town Vehari) from 21 Apr 2025 to 05 May 2025 in office hours and working days only.
- 4.7 Interested bidder/s must attached required documents of Eligibility and Responsiveness with Auction Documents. In case of failure, Bids will be rejected.
- 4.8 Late bids will not be accepted.
- 4.9 The validity of the offered bids must not be less than ninety (90) days from the date of bid opening.
- 4.10 In case of any disqualification (ineligibility or non-responsiveness) of most advantageous (highest) bidder, auction may be offered to 2nd most advantageous (highest) bidder after approval from Competent Authority.
- 4.11 Only that bidder will be allowed to participate in the bidding who has deposited Earnest Money (EMD).
- 4.12 The materials/items will be auctioned to the highest bidder of the respective Lots.
- 4.13 On completion of auction process, successful bidder shall deposit 25% of the total bid amount in the bank (NADRA Account NSRC Disbursement Account RHO NADRA Multan) on same day. Remaining 75% amount will be deposited in the concerned bank (NADRA Account) within 24 working hours after receiving letter from NADRA RHO Multan.
- 4.14 Successful bidders will remove the stores within 48 hrs after the complete payment.
- 4.15 If the successful bidder (s) fails to remove the stores within stipulated period. NADRA has the right to charge demurrage to the bidder @2% per day of the total bid amount.
