TERMS AND CONDITIONS

1. **Bidding Procedure:**
 - Single Stage-Two Envelope Procedure as per PPRA Rule 36 (a).
2. **Eligibility Criteria:**

Bidders must:

 - Be Registered with FBR (Valid NTN & GST)
 - Provide an affidavit of non-blacklisting
 - Show proof of similar supplier to the government / semi-government entities
3. **Bid Submission:**
 - Bids must be submitted on the PPRA EPADS system as well as to the Office of the **Director, Regional Meteorological Centre, Khyber Road Peshawar**, on or before 19-05-2025, 1100
4. **Bid Security (Earnest Money):**
 - 3% bid security of the total quoted amount (inclusive of GST) must be submitted as a Pay order/ Bank draft in favor of Director, RMC Peshawar in Pakistani Currency.
 - Bid without Earnest Money will be rejected.
5. **Bid Validity:**
 - The bids shall remain valid for a period of one and a half months (45 days) from the date of opening of the tender (Rule 28)
 - If required, the procuring agency may request an extension in the validity period, subject to the written consent of the bidder.
6. **Delivery Schedule:**
 - Items must be delivered within 15 days of issuance of the purchase order.
 - A 1% penalty per day will apply for delays beyond the specific time.
 - If the vendor fails to deliver the goods/services during the extended period, then the work order may be cancelled, earnest money and payment may be forfeited.
7. **Payment Terms:**
 - Payment will be made via Cheque through AGPR, after the inspection and satisfactory delivery by the Technical Committee.
8. **Taxes:**
 - Prices quoted must be inclusive of all applicable taxes.
 - Taxes will be deducted at source as per governments rule
9. **Rejection of Bids:**
 - The procuring agency reserves the right to reject any or all bid as per PPRA Rule 33.
