CORRIGENDUM

Reference is made to the tender notice issued vide PID(1)7148/24 for the project "**Provision and installation of Additional Stadium Lights at Jinnah Stadium, Pakistan Sports Board, Islamabad**". The following requirements, which are already a part of the bidding documents / advertisement, are hereby explicitly included in the eligibility criteria. Bids submitted without these mandatory requirements shall be treated as non-responsive and will not be considered for further evaluation:

1. Submission of an undertaking on the letterhead of the authorized dealer / distributor confirming that the specified lights are available with them.
2. Submission of a test report for the lights, in accordance with the required specifications.
3. Submission of a copy of the Authorization Letter issued by the OEM in favor of the authorized dealer / distributor.

In addition to above, successful bidder must deliver the requisite stadium lights on-site within seven (07) days of the award of work. Failure to comply with this requirement shall result forfeiture of the bid security of the contractor.

These additions, deletions, and amendments shall form an integral part of the Bidding Documents. Bidders are required to attach the original signed copy of this Addendum to the original bound volume of their Bidding Documents. Bidders must acknowledge and incorporate these changes while preparing and submitting their bids.

Interested bidders may visit the project site prior to bid submission. All other terms and conditions shall remain unchanged.

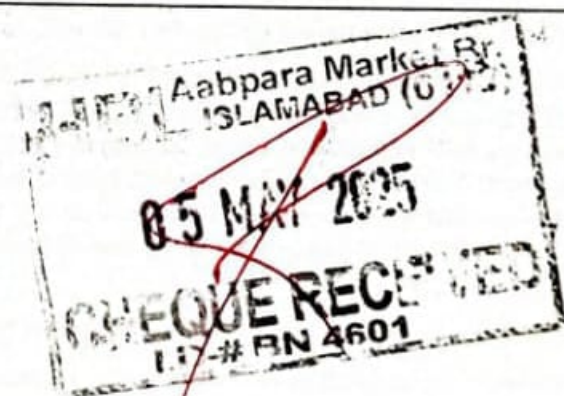
