CORRIGENDUM-02

1. Reference is made to the Tender Notice for the following works and the subsequent Pre-Bid Meeting held on **17-04-2025** at the Committee Room, Pakistan Sports Board, Islamabad:
 - I. **Supply, Installation, Testing and Commissioning of Electronic Display & Scoring System** at different facilities of Pakistan Sports Complex, Islamabad;
 - II. **Supply, Installation, Testing and Commissioning of Electronic Timing System Devices** in the premises of Pakistan Sports Complex, Islamabad;
 - III. **Supply, Installation, Testing and Commissioning of Diesel Generating Set (03 Sets)** at Pakistan Sports Complex, Islamabad;
 - IV. **Supply, Installation, Testing and Commissioning of Sound Amplification System** in the premises of Pakistan Sports Complex, Islamabad.
2. The Tender Notices were published in daily newspapers vide: PID No. (I) 6324/24 dated **15th March, 2025** for works at Serial No. I to III, and PID No. (I) 6691/24 dated **29th March, 2025** for work at Serial No. IV.
3. **Amendments** (Specific to Serial No. I only): The already uploaded Bill of Quantities (BOQ) only in respect of work at Serial No. I – "**Supply, Installation, Testing and Commissioning of Electronic Display & Scoring System at Different Facilities of Pakistan Sports Complex, Islamabad**" has been replaced with an updated version incorporating the previously missing details. The updated BOQ has been uploaded on the **EPADS** portal as apart of contract documents.
4. **Pre-Bid Meeting Minutes:** Minutes of the Pre-Bid Meeting held on **16-04-2025**, which addressed queries and clarifications from prospective bidders, are now available on Pakistan Sports Board official website: www.sports.gov.pk and Notice Board of the office of the Executive Engineer, PSB, Islamabad.
5. **Extension of Bid Submission Date:** The last date for submission of bids only for works at **Serial No. I, II and III** have been extended to **23rd April, 2025**.
6. These additions, deletions, and amendments form an **integral part of the Bidding Documents**. The original copy of this corrigendum shall be attached with the original bound volume of the Bidding Documents. Bidders are required to take these changes into account while preparing their bids.
7. Other terms and conditions remain unchanged. Bidders are requested to submit their bids after considering all provisions of the tender document, including this **Corrigendum No. 2**.
