

4. Bid Submission:

- All the firms are directed to quote their bids online through PPRA EPADS as well as original bids must be submitted in hard form along with Earnest money to the office of Chief Meteorologist, 46-Jail Road Flood Forecasting Division, Lahore
- Mark Envelope as: "Repair of furniture and fixture of 46-Jail Road FFD Lahore"

5. Bid Security (Earnest Money):

- Original 2% bid security of the estimated cost must be submitted as a Pay order/ Bank draft/Demand Draft in favor of Chief Meteorologist, FFD in Pakistani Currency.
- Bid without Earnest Money will be rejected.

6. Bid Validity:

- The bids shall remain valid for a period of two months (60 days) from the date of opening of the tender (Rule 28)
- If required, the procuring agency may request an extension in the validity period, subject to the written consent of the bidder.


