- a) The bids/proposals must be submitted through e-PADS as per PPRA specified procurement method **36 (a) Single stage - one envelope** on or before **07-05-2025** by **11.00 AM**. The Bids will be opened on the closing day at **11.30 AM**. Late proposal for any reason whatsoever will not be entertained.
- b) The firm must be having a registered office in Pakistan, Company registration certificates, valid NTN, and GST, as prerequisites for eligibility to participate in the bidding process.
- c) Modification, overwriting or cutting in the quotation or price will lead to rejection of bid.
- d) Incomplete or conditional proposals will be rejected. Partial bidding is not allowed.
- e) All prices must be quoted in Local Currency, inclusive of all applicable taxes, such as GST, Income Tax and Custom & Excise Duties etc.; otherwise, it will be assumed that the prices include all the taxes. PTV will not be responsible for any cost due to changes in tax rate by the Local or Provincial or Federal Government of Pakistan, at any time.
- i) No payment shall be made in advance. Payment shall be made after the delivery/inspection of the equipment and provision of the **"ANNEXURE-C"**.
- ii) The original bid security (refundable) of **Rs. 22,500/-**, in the form of "Pay Order"/ "Demand Draft"/ "CDR" in favor of "Pakistan Television Corporation Limited". The scanned copy of the draft is required to upload through ePADS and hard copy along with the bidding proposal must be submitted physically to "Chairman Senior Tender Committee" on or before the closing time of the tender. The bid without bid security or less than prescribed value will be rejected. Personal cheque/cash is not acceptable.
- f) The proposal must be valid for a period of **60 days** from the date of opening.
- g) Bidders are required to provide complete specification and warrantee (if any) of the quoted equipment.
- h) Provide **affidavit** on stamp paper that firm is not defaulter/blacklisted by any government institution and integrity **pact** duly signed & stamped by the firm.
- i) Clearly, mention delivery timeline, and no extension in supply of goods will be allowed.
