

    - Ownership of the firm. (on stamp paper of Rs. 200/-)
    - No blacklisting & No pending litigation. (on stamp paper of Rs. 500/-)
- 4. Bid security must be submitted in the form of a Pay Order / Bank Draft from any scheduled bank, drawn in favor of "Pakistan Civil Aviation Authority". The Bidders must submit their bids, bid security, and mandatory documents electronically through the PPRA EPADS Web Portal (<a href="https://eprocure.gov.pk">https://eprocure.gov.pk</a>) before the submission deadline. The original bid, bid security and above mentioned affidavits in 3 (e), must be submitted in person to the office of the Divisional Engineer Civil-II, JIAP, on the due date and time.
