TERMS & CONDITIONS:-

1. Tenders documents can be purchased up to **11-09-2024** from the office of undersigned during office hours on payment of prescribed tender cost (non-refundable) on written request. Tender fee is also acceptable in shape of Pay Order/Bank Draft of any schedule bank in favour of “**Civil Aviation Authority**”. Tender fee may also be submitted in CAA Revenue Account No.**0211-00432179-03** at MIAP, Multan and receipt may be produced to this office with written request.
2. Tenders will be received on **12-09-2024** at 1100 Hrs. and will be opened on the same day at 1130 Hrs. in the Office of undersigned in the presence of intending contractors or their representatives.
3. Earnest Money amounting to Rs.30,000/- in the shape of Pay Order/Bank Draft of any scheduled Bank draw in favour of “Civil Aviation Authority” should be submitted along with the tenders in separate sealed envelope. Tenders without earnest money would not be entertained. Pay Order / Earnest Money of the unsuccessful bidders will be retained till finalization of tender process.
4. No tender will be sold by post or on the date fixed for opening of the tenders.
5. Conditions tenders shall not be entertained.
6. The bidders will have to provide the following, prior to issuance of tender documents:-
 - a. Affidavit of proprietorship duly attested on non-judicial stamp paper of minimum Rs. 200/- (if applicable).
 - b. Affidavit of no litigation on non-judicial stamp paper of minimum Rs. 200/-.
 - c. Power of attorney on non-judicial stamp paper of minimum Rs. 500 (if applicable).
 - d. Valid income tax, sales tax and professional tax registration, active tax payer status and NTN certificates.
7. Tender shall only be issued to authorized representative of the Contractor/Firms/Company etc having proof of authorization of the respective Firm/Company/Contractors.
8. Tenders documents will not be issued to contractors / firms whose past performance with PCAA/ PAA is unsatisfactory or any litigation / debarring / blacklisting case of them is in progress.
9. PAA reserve all rights to accept or reject any or all the tenders for sufficient and cogent reasons which will be communicated to the bidder on request. Conditional Tenders shall not be entertained and liable for rejection.
